- We will be having Obedience & Rally at the October 2024 Specialty because we already have a judge.

Scent Work Trial - September 20 - 22, 2024:

- We will split the cost of the site with Abbadogs Agility.
- The show is 70% full, so far.
- We will have Detection Dog on Friday this event takes time and there are a lot of people looking for it.
- The ribbons alone showed bring in entries.

Website:

- The Board discussed the situation and agreed that hiring Lisa S to continue to monitor our website would be a good idea.

- Vet Issues Blog on Website:

 - The Judges Committee circulated ballots with nominees for judge at the October 2025 Specialty (Note: we will no longer have Sweeps at our October show starting in 2025),

Old Business:

- Sweeps:
 - Sweeps is where we train our judges, so it is important to keep these classes, but not necessarily at both Specialties.

- Sweeps loses money and dealing with the award envelopes is a hassle.
- Sue Cone will talk to Ba-Ray to see if they have a different way to calculate Sweeps winnings.
- Some Clubs give only ribbons. Other Clubs just give a flat amount (say,) to the Best in Sweeps.
- **Obedience Special Awards:**
 - The Board voted to discontinue the Obedience Special Awards because most awards are not handed out and, when they are, they are often won by the same person. They are obsolete and the money could be used elsewhere.
 - Bev suggested using the saved by discontinuing the Obedience Awards to upgrade the flat ribbons to rosettes for Obedience & Rally. Rosettes encourage people to enter shows.
 - Motion by Bev: That we use the usually spent on the Obedience awards to get rosettes for Obedience and Rally.

Good of the Order: No report.



COMMON MEDICAL ISSUES IN SHETLAND SHEEPDOGS Part III

NEW LYMPHOMA TREATMENT

This month I am going to introduce you to a new chemotherapy drug for the treatment of LYMPHOMA. It is called LAVERDIA-CA1.

LAVERDIA-CA1is given twice a week orally. You must use protective disposable chemotherapy resistant gloves when administrating the drug which is normal practice. It comes in an easily administered tablet- just put it in a pill pocket. It is NOT to be used in pregnant, lactating or dogs intended for breeding. This drug can adversely affect female and male fertility. When using this drug frequent monitoring of bloodwork is necessary.

The most common side effects are: anorexia, weight loss, vomiting, diarrhea, lethargy, pu/pd, increased liver enzymes, and thrombocytopenia. It sounds like the side effects of most of the medicine we take.


